## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## Product

'Metfriendly Monthly Savings ISA' is manufactured by Metropolitan Police Friendly Society Limited (Metfriendly). ## What is this product?

Objectives	The Monthly Savings ISA's objectives are: <ul style="list-style-type: none"><li>• To grow the value of investments over time</li><li>• To shield the growth from income and capital gains taxes</li><li>• To allow for flexible savings and encashment</li></ul> Your premiums are invested in Metfriendly's With-Profits fund which is made up of equities, commercial property, bonds and cash. At the end of each calendar year, we normally add a bonus to all your investments and send you a bonus notice. Once added, bonuses are permanent additions to your investment with us. Provided you invest for at least 3 complete tax years, we normally add a final bonus when you cash it in. A key factor in determining bonuses is the investment return on the With-Profits fund in recent years.

## What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 10 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Metfriendly to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. If Metfriendly is not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section 'What happens if Metfriendly is unable to pay out?'). The indicator shown above does not consider this protection.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

## How long should I hold it and can I take money out early?

### Recommended holding period: 10 years

You can invest for as long as you want; there is no fixed term and no maximum age limit. You should bear in mind that the plan is designed as a medium to long term investment (5 years or more). You can contact us at any time to cash in part, or all of your plan. A 5% penalty is applied on cashing in or transferring out within one year of opening your plan and a 3% penalty is applied on cashing in or transferring out during the second year.
